MOTION to require that teams who hire Jr Coaches for team-level development must provide an equal amount of paid sessions to the volunteer sessions they did for the team, once their 12 volunteering hours are complete. For example, if a Jr Coach worked 3 shifts as a volunteer on a team, that team will commit to 3 paid sessions for a total of 6 sessions for that team. If a Jr Coach did all 12 volunteering sessions with one team, then the team would be obligated to provide 12 paid sessions. Teams are not obligated to have a Jr Coach at all 12 of their volunteer sessions, but however many they do use them for, must be matched with paid sessions.

 Jr Coaches are responsible for tracking their own volunteering sessions, and on which team they complete them with.
