Financial Statements

- Profit and Loss Statement \$48k Surplus
 - Increase in training and development costs– Midget Mentoring increased, 2 RIC's and increased Ref mentoring costs, and fee paid for TOC. Camp fees remained consistent.
- · Balance Sheet
 - \$250k in Cash
 - Net Equity of \$350k

Questions and comments:

- Is the \$100k Grant not listed? It is listed for 22/23 Season
- · Clarification on how the fiscal year works
- Question on training and Development Costs why did it increase so much? (as noted above)
- Are our accounts audited? No (Members can ask for an audit though)
- Last year we had external firm provide statements, but they were not audited
- Financial Statements should be provided in written copy? No, it is not required in our bylaws.
- Members are requesting detailed line items for salaries and some line items in financial statements (TOC, Admin, Registrar, development)
- Why were financial statements not prepared earlier? Challenge with year end deadlines. Last year we paid an external accountant. We were also missing a bookkeeper for first half of the season.

2023/2024 Budget

- · We are seeing increased expenses for inflation, increased TOC Costs and Ice
- Budget is being presented as "draft" and to be determined by new board
- Proposal is to increase in registration by \$100 (not accepted by current sitting board)
- Gaming grant was denied due to financial surplus. (We did not have access to some of registries information due to vacant admin role, and also that we have too much in existing funds – we did not show sufficient need)
- Member request: to see the grant application and the rejection letter.
 - Displayed on screen
- Member Question: why are we increasing registration if we have such a big surplus? (increased costs). Haven't increased fees in several years.
- The budget is not up for approval it will be voted in by the new board. It is presented for feedback only.
- The deadline for the gaming grant for the coming season Is this being prepared?
- Should we move the treasurer position off the board. What can we do to prevent the late gaming grant application from happening again.
- Professional Fees why is it an increase in professional fees? Legal Costs due to pending lawsuit.
- The fees for the camps can be increased
- Where is the development line item going?

- \circ Why not delay a year until we have a gaming grant? $\$
 - Development program was voted in before gaming grant was denied and lawsuit was filed.
- Where is the fear of running out of operating fees stemming from? (No increased development revenue)
- Are ice rates set for next year? (No)

- Question to Kelly Lawrence What are your current challenges? Finding coaches
- Question: What is your position on parent coaches at the rep level?
 - Ryan Just because you are a paid coach doesn't mean you are a good coach.
 Supports parent coaches if they are experienced and good. Would like to support Jordan in his role.
 - Justin Considers that in parent coaches that there would be favoritism and understands the reluctance but with the shortage of good coaches he would consider parent coaches if there were proper policies put in place. Parents should not be automatically disqualified from coaching a rep team
- Will there be a review of how C teams are balanced? We are aware and a committee was put together to review the procedure and produce a new procedure. It has been updated with 2 members at large.
- What can be done if we are on an unbalanced team? The division coordinator will not stop until teams are balanced with balancing games. TOC's will help with oversight. Coordinator will not be someone from the division.
